Μέ αἰσθήματα χαρᾶς καί ἀγαλλιάσεως σᾶς καλωσορίζω εἰς τήν ἐτήσια Κληρικολαϊκή Σύναξη 2018, καθώς καί εἰς τήν Συνέλευση τῆς Φιλοπτώχου Ἀδελφότητος τῆς Ἱερᾶς Μητροπόλεως Νέας Ἱερσέης. ## Metropolis of New Jersey Clergy/Laity Assembly Minutes May 8-9, 2017, Garfield, New Jersey

#### 1. OPENING

The 2017 Greek Orthodox Metropolis of New Jersey Clergy/Laity Assembly officially opens on Monday, May 8 at 10:10 A.M. with the chanting of Xristos Anesti followed by a Prayer Service.

#### 2. APPOINTMENT OF CHAIRMAN

His Eminence Metropolitan Evangelos declares the Assembly open at 10:20 A.M. He introduces the dais and appoints James C. Fountas, Vice President of the Metropolitan Council, as Chair of the Assembly. His Eminence also introduces a delegation from the Archdiocese Department of Administration and Finance consisting of Mr. Jerry Demetriou, Mrs. Niki Soteropoulos Margaritis, and Mr. George Papadakos.

#### 3. GREETINGS

- a. James C. Fountas welcomes the delegates and attendees to the Clergy/Laity.
- b. Rev. Fr. Elias Noplos, President of the Metropolis of New Jersey Clergy Syndesmos, greets the delegates and all present. He thanks His Eminence for bringing us together to share in the ministry work of the Metropolis and for this fellowship opportunity. From this gathering, we will discuss many issues that will help guide our Metropolis. He informs the Assembly that the next National Presbyter's Retreat will be held in the Metropolis from October 31 to November 3.
- c. Anne Michaels, President of the Metropolis Philoptochos, thanks His Eminence for the love and support he offers Philoptochos. Philoptochos continues to work for the betterment of our church. She informs the

Assembly that a new Philoptochos Chapter in Darlington, Maryland has been established, Chapter #143.

## 4. ARCHPASTORAL EXHORTATION OF HIS EMINENCE METROPOLITAN EVANGELOS

• Please refer to written text.

His Eminence welcomes all dignitaries and delegates. His Eminence reminds us that we are members of the One, Holy, Catholic, and Apostolic Church whose head is our Lord, Jesus Christ. In past years, remarks were offered on the progress, work, and ministry of the Metropolis but today focus will solely target the theme of the Clergy/Laity: "Assuredly, I say to you, unless you are connected and become as little children, you will by no means enter the kingdom of heaven." - Matthew 18:3. Specifically, the future of our church - our youth and children. This theme follows the Patriarchal Declaration proclaiming 2017 as: "The Year of Protection of the Sacredness of Childhood" in which we are urged to respect the rights and privacy of children. His Eminence expounds on the Patriarchal theme. The Orthodox believe in the sanctity of life even from the mother's womb. A Youth Protection manual is currently being compiled by the Archdiocese and will be made available to the parishes at the 2018 National Clergy/Laity. His Eminence offers statistics regarding crimes against children in the United States. The Metropolis will launch initiatives in the four various regions to help combat narcotic abuse by bring awareness to its associated dangers. Ministries such as: St. John Chrysostom Oratorical Festival, Camp Good Shepherd, Religious Education, GOYA retreats, Bible studies, Greek school, all help develop and educate our children in the faith. His Eminence also presents statistics regarding literacy in America. Every important social issue is impacted by low literacy. When individuals learn how to read, write, do basic math, and use computers, they have the power to lift themselves out of poverty, lower health care costs, find and keep sustainable employment, and ultimately change their lives. Those who lack proficiency and basic education may turn to crime. Parents must spiritually nurture the youth.

#### 5. PRESENTATIONS

a. "Liturgy as Catechesis: Unlocking the Treasures of Liturgical Life" – Rev. Fr. Stefanos Alexopoulos, Ph.D. Assistant Professor of Liturgical Studies and Sacramental Theology, The Catholic University of America School of Theology and Religious Studies, Washington D.C. How do we attract,

retain, and catechize our youth? Fr. Stefanos offers practical ways to use Church prayers, hymnology, teachings, and dogma for catechesis.

b. ORDER OF ST. ANDREW THE APOSTLE, ARCHONS OF THE ECUMENICAL PATRIARCHATE - Archon Constantine Caras The actions of the Ottomans seem to indicate that they are trying to extinguish the Patriarchate. 1.) By seizing and overtly confiscating property, and by levying discriminatory taxes. For example: In 1920, there existed some 8,000 pieces of property in Constantinople/Turkey; in 1990, this number was 2,000; today, it is under 500. To note: some of these confiscated properties were income producing; most, however, are not and require substantial financial resources to maintain. 2.) The Patriarchate is denied legal standing. Churches and properties are owned by minority foundations (no clergy can be members of a foundation). The Turkish government is not replacing board members upon death. As a result, when a property deteriorates, no one is able to petition for permits. Many of the current properties are in various stages of decay. Because of this, the government confiscates these properties labeling them as hazardous. 3.) The Patriarchal Seminary on Halki remains closed. The Turkish government insists that no private institution can teach religion. 4.) The Turkish government routinely interferes with Patriarchal elections. Every patriarch must be a Turkish citizen, as well as, every voter. 5.) Many churches are being converted into museums or mosques. In 2012, the historic church of St. Sophia in Nicaea, dating from 1200 A.D. was made into a mosque. Twelve churches by the same name of St. Sophia have been converted into mosques; also of note is the church in Trapezounta. Last year's annual celebration at Panagia Soumela was cancelled. Also troubling is the daily Muslim call to prayer now being broadcast from inside the Great Church of St. Sophia in Constantinople.

c. ST. NICHOLAS GREEK ORTHODOX CHURCH AT WORLD TRADE CENTER – Jerry Demetriou

A brief update is given on the reconstruction effort of St. Nicholas G.O.C. at World Trade Center. Mr. Demetriou thanks His Eminence and the Metropolis for the effort to help rebuild. The Metropolis of New Jersey currently ranks second in this effort. A total of \$558,749 has been contributed from 53 parishes in Metropolis. The Metropolis of New Jersey Philoptochos was the first to fulfill its pledge by donating \$300,000. A review of the history of St. Nicholas and the new architectural design is offered. Total funding for the project: \$46,392,702 is pledged with \$35,458,012 received as of May 5, 2017. His Eminence wishes to raise the

Metropolis' commitment to St. Nicholas to \$1 million. Targeted completion date is August/September 2018 with the Thyranixia in October 2018.

d. GREEK ORTHODOX ARCHDIOCESE FINANCE REPORT - George Papadakos

A Summary report of the GOA Finances with Questions and Answers (Q&A) ensues. The entire report will be made available, upon request, to the Metropolis of New Jersey.

e. DIRECTOR OF OFFICE OF DEVELOPMENT - Niki Sotiropoulos Margaritis

This new Department at the Archdiocese will focus on fundraising efforts. The Development Office will build and strengthen relationships, as well as create and execute strategic plans by connecting those with financial means to the Archdiocese. It will search for funding by inspiring joyful and generous charitable giving. The office is currently developing a two-year strategic plan to inform parishes of its objective.

f. GOMNJ STEWARDSHIP/TOTAL COMMITMENT – Peter Arbes A summary of: 1.) the 2016 Total Commitment; 2.) an update of the 2017 National Ministries Commitment; 3.) A preview of National Ministries Commitment. Funding supports the Ecumenical Patriarchate, Metropolis of New Jersey, and Archdiocesan and National Ministries. 2016 Commitment was \$2,447,053 without cushion. The cushion was \$122,165. The Metropolis has collected \$2,469,196 which represents 101% of its total. For six of the last seven years, the Metropolis has reached 100%. 2017 -Archdiocese Commitment is \$21,541,019, an increase from \$20,085,000 or 7.25%. 2017 Metropolis Commitment increases from \$2,447,053 to \$2,597,460 or 6.15%. 2017 total is \$2,698,276 (with a \$100,816 cushion). To note: 84% funding of the Archdiocese is from National Ministries Commitment (parishes' contributions). The 2018 Archdiocesan Budget will increase to \$30,259,407 or 5.8%. Deadlines for submitting data forms was April 21, 2017. All parishes in the Metropolis, except three, hit the 2016 Honor Roll or 100%. Q/A are entertained.

g. SAFETY AND SECURITY OF OUR PARISH/COMMUNITIES -John Chrisomalis

Three questions must be asked regarding the security in our parishes: 1.) does each parish have a security director; 2.) are there designated safe rooms/spaces in our churches; 3.) does each parish have procedures for youth pick-up. It is suggested that those working with the youth, finances, or on the Parish Council have background checks conducted. Internal investigations are recommended to counter the potential of property theft, internal audits, and physical threats. A building assessment is needed to

help uncover any security breaches and/or to deem a parish safe. Lockdown procedures need to be in place with the process recorded in writing. Also begin a conversation regarding an "active-shooter" scenario.

- h. GOMNJ PARISH ADMINISTRATION Constantine Economides Currently, the Metropolis is dealing with an issue regarding donations made to parishes that do not have their own 401-3c. The Metropolitan directs each parish to send a copy of its parish's papers of incorporation.
- i. RELIGIOUS EDUCATION Rev. Fr. Anargyros Stavropoulos
  The Religious Education program of the Metropolis offers creative and mature resource materials to teach the faith. History has shown that the mission of the parish's catechetical school is to build-up the church and body of Christ by nurturing each person. Through it, we communicate the Christian creed, make firm our belief, develop a course of prayer, learn about the faith, grow by sharing, caring, and witnessing. His Eminence has created four regions in the Metropolis of New Jersey in which Religious Education seminars held each year. Agapios Kyritsis is invited to give a summary of the Religion Education Workshop. Q & A. His Eminence asks that next year's Clergy retreat have a theme based on effective Religious Education. Spiro Spireas pledges \$200,000 from SigmaPharm Laboratories to fund Religious Education improvements and pay for ongoing education of volunteer teachers.
- j. GREEK EDUCATION Presvytera Eleni Alexopoulos
  Presvytera Eleni shares notes from the Greek Education Teacher's Seminar held at St. Thomas G.O.C. in Cherry Hill, NJ in the Fall of 2016. What are present challenges? Tools, material and equipment, applying new technology. The profile of the typical student has changed significantly over the past decade. There is a greater disconnect from these students with the Greek heritage. Teaching methods have to change to address this situation. The Greek language must increasingly be taught as a foreign or heritage language. Schools are not engaging with the new type of Greek-American family in which most children are of a third or fourth generation whose house also has one non-Greek parent. Investment into the development of this methodology of teaching is needed. It is recommended that parishes

- cover the cost for teachers who attend conferences to further develop teaching skills.
- k. YOUTH MINISTRY Rev. Fr. Anastasios Bourantas, Rev. Fr. Peter Zougras, Rev. Fr. John Emmanuel, and Rev. Fr. Andrew Eugenis Each presenter offers a summary of the various youth ministries in the Metropolis.

# The National Herald reports on 'Mike Psaros in the Process of Transforming the Greek Orthodox Church in America'

In the February 10-16, 2018 weekly edition of *The National Herald*, a Greek-American publication, Theodore Kalmoukos, Religion Editor, interviewed Archon Michael Psaros who addressed the recent progress made within the Greek Orthodox Archdiocse of America. The interview in its entirety is published below.

## Mike Psaros in the Process of Transforming the Greek Orthodox Church in America

Michael Psaros, a prominent businessman with expertise in how to rehabilitate troubled organizations is in the process of transforming the Greek Orthodox Church in America, whose dire financial situation brought it to the brink of bankruptcy.

With his keen acumen, he spotted the numerous flaws in the Archdiocese's managerial infrastructure, including a virtual absence of internal controls.

As Archdiocesan Council Treasurer and a man of deep faith and great love for the Church and the Greek-American community, he alerted Archbishop Demetrios, whom he respects a great deal, informing him that unless specific measures are taken, the Archdiocese's well-being will remain in visible danger.

In an exclusive interview with The National Herald, Psaros is open, honest and transparent in explaining the progress that has been made during the past six months and a transformation that appears visible. A son of the All Saints parish of Weirton, WV, Psaros could very well go down in history as the one who transformed the Orthodox Church in America.

The complete interview follows:

#### TNH: What is the financial condition of the Archdiocese today?

PSAROS: By the Grace of God, the Greek Orthodox Archdiocese of America (the "Archdiocese") announced, pursuant to a press release dated January 26, 2018, that it completed an ambitious restructuring process that greatly advanced the financial stability of the Archdiocese.

The Archdiocese is now projected to achieve a balanced budget and generate additional funds that will be applied to retire its financial obligations.

The financial stability of the Archdiocese was achieved without any additional burden placed on its parishes. This is critical. Parish contribution levels in 2018 were maintained at the 2017 levels, resulting in a \$1.6 million of savings to our parishes.

The Archdiocese is fundamentally transformed from an administrative and financial perspective. This transformation was achieved in a period of only six months. A significant number of decisive actions were implemented by the Archdiocese that are very impactful individually, but transformative, collectively.

My firm is one of the world's most successful turnaround investment firms. This is my profession for almost three decades -- this is what I do. However, even I am surprised with the speed and effectiveness of the changes. Everyone knows that change is difficult, and that it is difficult for people and organizations to change. Even though the Holy Archdiocese is a canonical, hierarchical, traditional, ecclesiastical institution, it successfully managed through a period of extreme change as well as any organization I have observed.

The Executive Committee, the Officers and Committee Chairs of the Archdiocese are now focused on the future and only the future. While it is exceedingly disappointing and unfortunate that the Archdiocese experienced a period of financial extremis in its recent past, it can never be allowed to happen again in the future.

#### Everything is new:

The Archdiocese is now led by new senior lay leadership at the most senior level, led by Archon George Tsandikos, Vice Chairman, Ms. Cathy Walsh, Secretary, and me, serving as Treasurer.

The Archdiocese is now under new management and has a critical new organizational structure. His Grace, Bishop Andonios, Chancellor, assumed key administrative responsibilities after the resignation of the former Director of Administration in September 2017. Father Soterios Baroody was appointed as Chief Financial Officer ("CFO") of the Archdiocese in April 2017. Prior to his appointment, the Archdiocese did not have the position of CFO, and, in addition, prior the creation of the CFO, the former Executive Director of Administration had control of

Administration and Finance. There has now been a clear separation of these functions.

Please note that the Archdiocese former Executive Director of Administration resigned, and the former Director of Finance was terminated. In addition, the former Chairman of the Finance Committee was relieved of his position.

Archon Lazaros Kircos was appointed as the new Chairman of the Archdiocese Finance Committee in October 2017. Under Archon Kircos' leadership, the Finance Committee has taken its expanded role, not only responsibility for the success of the Archdiocese Total Commitment Program, but also its proper role in leading and monitoring those of areas involving budgets, expenditures, finance, treasury, and long term strategic planning. Chairman Archon Kircos has already made numerous critical contributions, especially in the development of the 2018 Budget.

Ms. Elaine Allen was appointed as the new Chairperson of the Archdiocesan Council's Standing Independent Audit Committee, accompanied by a new group of very qualified and credentialed (emphasis on qualified and credentialed) financial and legal professionals who serve as members of the Committee. Ms. Allen, Chairperson of the Audit Committee, has already made an enormous impact on the operations of the Archdiocese. From a personal perspective, she is one of the most impressive professionals I have ever observed at work after almost 30 years on Wall Street. We are so blessed to have her working on behalf of the Archdiocese. The responsibilities of the Audit Committee include assessing the reliability and accuracy of financial reporting; selecting external auditors; meeting with those auditors to review audit plans and results; reviewing internal controls and developing any necessary remediation plans; and monitoring compliance with applicable laws and regulations pertaining to financial controls.

Please note, so I do not have to repeat myself after every reference to specific actions below, that the Officers and Committee Chairs, only act under the direction of, and with the blessings of, His Eminence, Archbishop Demetrios, Geron of America.

The Leadership Team is committed that the Archdiocese will become a world-class, not-for profit institution from an accountability, transparency perspective.

From a very personal perspective, this Leadership Team is working tirelessly, continuously, methodically, analytically and professionally to address the Archdiocese's administrative and financial challenges. We are all volunteers, with our own careers, families and numerous other obligations, but we have devoted everything to the Church over the past year.

#### How did the Archdiocese achieve financial stability?

The Archdiocese achieved stability primarily by (Step 1) establishing new leadership as already discussed, accompanied by critical organizational changes, (Step 2)

establishing new internal controls, policies and procedures governing spending, and (Step 3) significantly reducing its operating cash cost structure by reducing expenses resulting in a new cost structure.

Step 2: Implement internal controls, policies and procedures governing spending

Establishing internal controls, policies and procedures governing expenditures was critical to achieving financial stability. In Spring 2017, the Archdiocese started the process of improving internal controls by management directive. For example, it began to implement policies and procedures governing travel and expense accounts, general and administrative expenditures, staff cell phones, and credit card usage. Further, new vendor management protocols and controls were implemented. While these actions were very effective, they were not enough.

The Officers are determined to create a world-class ecclesiastical not-for-profit institution from a governance and controls perspective. In furtherance of this objective, the Archdiocese retained Grant Thornton to conduct a thorough, independent review and analysis of the operations of the Archdiocese finance function, and to provide an in-depth, third party view of areas where the finance function and the Archdiocese can become more efficient, effective and transparent.

The Archdiocese Council, including its Executive, Audit, Legal and Finance Committees, received the Executive Summary of the Grant Thornton Operations Review in January 2018. The Operations Review makes recommendations on best practices that can be implemented and will act as a critical guide for the Archdiocese regarding internal controls, practices and procedures.

#### Step 3: Material Reduction in Operating Cash Costs

The Archdiocese reduced approximately \$8 million or approximately 25% of annual operating cash expenditures, thereby eliminating its former structural operating deficit. Approximately \$6.5 million, of the \$8.0 million in expenditure reductions were implemented in August-September 2017, with the balance in January 2018.As a result, the Archdiocese now has a budget where receipts exceed disbursements, and extra funds can be used to repay prior financial obligations. The cost reductions, which are permanent and structural, were achieved primarily by reducing Archdiocesan staff levels, reducing general administrative costs, and implementing new vendor management protocols and controls.

Speaking personally, please allow me to make two observations.

First, I ask you, humbly and respectfully, to consider the magnitude of the cost and spending reductions that occurred, and reflect on how quickly and decisively the Archdiocese acted. Substantially all of the \$8 million in cost cuts involved people and payroll. Reducing such a significant number of loyal, dedicated, committed and faithful employees was very difficult. This action effected many families, and these

reductions were only made after very thoughtful considerations. In addition, a large number of non-employee professionals on payroll, from outside vendors and contractors, were also eliminated.

Second, I ask you again, how many families, companies, or organizations could cut 25% of their total operating expenditures at all, or in such a short period of time?

#### When did you start, and how long did it take you?

We are now one year into our work; the actual transformation of the Archdiocese has taken place over the past six months. The condition precedent was the creation of the CFO position first in April 2017. Once in his position as CFO, Father Soterios Baroody worked very hard between April and July2017 to first understand, and then present, the true and accurate financial status of the Archdiocese to His Eminence, His Grace and the Officers in late Summer 2017.We reacted immediately.

#### What is the budget for 2018?

The Executive Committee approved a budget that reflects the true financial position of the Archdiocese. As Treasurer, I will work with the Finance Committee of the Archdiocese to monitor variances in the new budget relative to actual performance. This budget process is a first and critical step in establishing a solid foundation for the Archdiocese finances.

The 2018 Budget will be posted on the Archdiocese website in the near future.

#### What else needs to be done?

There are three critical tasks before us (1) documenting, implementing, communicating and enforcing the recommendations of the Grant Thornton Operations report. This will make the changes structural and permanent, (2) satisfy certain financial obligations and liabilities, and (3) establish a plan to restart the construction of St. Nicholas National Shrine.

The Archdiocese has disclosed that it is regrettably encumbered by certain legacy obligations resulting from its former financial problems. The Archdiocese has retained professionals to determine the quantum and nature of these liabilities. Further, very regrettably, the Archdiocese also disclosed that certain custodial and restricted accounts were used to fund operations. The Archdiocese is prioritizing the expeditious return of funds to the custodial and restricted accounts. This may be accomplished either by (1) funds generated through operations (funds have already been returned in this way), or (2) perhaps, by borrowing from a third-party bank or financial institution to immediately refund these obligations. This potential third party loan would be repaid over time. Having not made the decision at this time, obviously the quantum of the potential loan has not been determined. You should note, that while the Archdiocese has collateral (land and buildings) available for a loan, that fact

alone is not sufficient. The only reason the Archdiocese is in a position to consider the option of obtaining a loan is because it achieved financial stability and is generating funds available for debt service.

The Archdiocese currently has no third party debt but has had debt in the past which it repaid.

## Do you think a full disclosure can be given at the Clergy Laity Congress in Boston in July?

Since October 2017, the Archdiocese has released a constant stream of press releases. It has informed the Faithful of key events happening in very real time. The Officers have given speeches, held talks, and addressed Metropolis Clergy Laity meetings. Consistent with this practice, the Archdiocese will continue to provide full disclosure in Boston and beyond.

## In what condition did you find the finances of the Archdiocese when you assumed office?

I spoke very directly with His Eminence, Archbishop Demetrios. Please understand for someone raised like me, with respect/sevasmo, this was very difficult. To his eternal credit, he asked for the truth and asked me to be blunt. My response was clear and direct: he had been let down in the worst way possible. The Archdiocese was not well run by the lay people in whom he put his trust. In my professional opinion, everything was broken and needed to be fixed. And if anyone disagrees with my characterization, please explain to me how the Archdiocese ended up with structural operating deficits (now solved), significant lack of internal controls governing expenditures and other matters (now solved), an Audit Committee constituted by individuals not qualified to serve on an Audit Committee (now solved), various conflicts of interest from an organizational perspective (now solved), and funds that must be replaced in custodial and restricted accounts (a problem to be solved). The list is much longer. I could continue, but I will stop. To his eternal credit, his Eminence, Archbishop Demetrios, asked us to proceed expeditiously with our work. He issued this instruction with confidence and conviction.

#### What kind of an Archdiocese will the new Archbishop find?

He will find today an Archdiocese that has achieved financial stability, and as discussed above, having already made great progress towards having proper and professional governance and controls. Sometime in the immediate future, he will find an Archdiocese that has not only achieved financial stability, but which has either partially, or entirely, dealt with its financial obligations.

#### Have the Parishes been supportive?

The strong stewardship by its Parishes is extraordinary. In January 2018, the Finance Committee reports that for 2017, the Archdiocese Total Commitment receipts from its parishes across the country met 100% of the budgeted Total commitment for the sixth consecutive year.

I do not deal in headlines, I deal in reality. I am a financial person. I look at the numbers. Math is objective. Math tells the truth. The truth is the financial support of the Parishes has been, is and continues to be extremely strong. Further, many Parishes from all over the country are taking advantage of the financial incentives involved with pre-paying their respective assessments.

The Archdiocese is deeply indebted to the parishes and is grateful to God for them.

## When do you think a full and comprehensive report will be sent out with numbers including St. Nicholas?

The Archdiocese is committed to the rebuilding of Saint Nicholas National Shrine and the fundraising efforts to support this important project.

PricewaterhouseCoopers LLP (PwC) and Baker Hostetler LLP have been retained to conduct an independent investigation of the rebuilding of Saint Nicholas. These firms are reporting to an independent committee. This is a very difficult task that must be, and will be, done right. At this time, we do not know the expected completion date of PwC's work.

## **District/Metropolis Level**

The District/Metropolis Director will, twice a year, certify to the Archdiocese that:

- 1. the District/Metropolis has received Certification Letters from parishes; and
- 2. a random spot check of parishes has revealed no issues with the certification letters.



#### **Archdiocese Level**

The National Director will, twice a year, certify to the Legal Committee that:

- the Archdiocese has received Certification Letters from the District/ Metropolises; and
- 2. a random spot check of parishes has revealed no issues with the Certification Letters.



#### VOCAL ABUSE IN ORTHODOX CLERGY, PSALTAI, AND CHURCH MUSICIANS

(This publication was developed by three members of the National Forum of Greek Orthodox Church Musicians who are also otorhinolaryngologists. Nicolas Maragos of Rochester, MN, was lead author of the article, with assistance and review from George Demos of Denver, CO, and William Harmand of Syracuse, NY.)

Have you ever experienced a time when your voice was just about to "give out on you," or you had a hard time hitting the "high notes?" Did you ever sound "raspy" or "hoarse?" These symptoms signal voice trouble from abuse, misuse, or overuse, symptoms that may appear slowly or suddenly after strenuous chanting, reading, and singing in Church. Whatever the cause, vocal abuse will eventually take its toll on the voice, leaving it with less agility, range, and pure sound.

The physical demands even during the "routine" Sunday liturgy can be very stressful for the unprepared voice. Worship services are long and require the full range of vocal control. Preparing for Holy Communion or fasting dries the throat, increasing vocal stress. Only the best-trained voices will survive without minor disturbances, so proper vocal preparation is also of great value.

The purpose of this publication is to outline the proper techniques vocal health, hygiene, and voice production which will create the *least* amount of stress on the singing voice, and allow the "joyful song" to be a truly joyful experience.

#### Symptoms of Vocal Abuse

Awareness of the symptoms of vocal abuse and preventive attention to the care of the voice will prevent most serious troubles. The symptoms of vocal abuse, given in order of increasing severity, include:

- 1. Dryness of the throat
- 2. Fullness or "lump" in the throat

- 3. "Excess mucus" in the nose and throat
- 4. Vocal fatigue after a period of voice use
- 5. Throat irritation or soreness
- 6. Loss of vocal range (especially the higher notes)
- 7. Raspiness
- 8. Hoarseness

#### Causes of Vocal Abuse

1. Throat dehydration

There is nothing more important to the good vocal health than keeping the vocal folds moist with mucus. Mucus in the throat is normal. The nose and sinuses produce approximately one to one-and-a-half quarts of mucus every day, washing down the throat to coat and clean this entire area. When we "feel the mucus", however, it has become too thick and dried out, and unable to protect the throat from bacteria, viruses, and dust. The vocal folds also use mucus to slip easily past one another during sound production. Without sufficient mucus the folds work harder to produce sound, creating tissue tension and heat build-up. Normal watery mucus will efficiently evaporate this heat away, preventing tissue damage.

#### 2. Voice Strain

Talking too loudly or too long, or using the voice when physically fatigued causes vocal tension and overexertion. However, the most important abuse is vocal use or overuse in the presence of a viral upper respiratory infection (a "cold"). Viruses cause irritation, swelling, and inflammation (redness) of the vocal fold lining *mucosa*, thickening of the mucus, and dehydration. Singing "through" the throat irritation is very harmful, adding insult to injury. The excuse of "I had to sing because I couldn't get out of it" is pretty feeble when considering the severe long-term consequences of singing during a "laryngitis."

3. Throat Clearing

Throat clearing with a guttural sound produced is a habit to be condemned because it brings the two vocal folds forcefully together, causing much irritation. Drinking water whenever you feel the need to clear the throat will keep the mucus thin and prevent injury to the lining tissue from this habit.

4. Smoking

The far-reaching hazards of tobacco smoke are well known. Cancer-producing chemicals in the smoke and tar inflame the vocal fold surface, and the hot, dry smoke cause irritation with eventual changes of thickening, swelling, or polyp formation. With time, the *mucosa* becomes so irritated that it will begin to grow wildly and produce a cancer. Despite knowledge of these serious consequences, it remains astonishing that a full 20-30% of our population continues to smoke cigarettes, endangering both their own health and that of those around them.

5. Drinking

Alcohol is a chemical irritant of both the breathing and swallowing tracts. Alcohol also has a diuretic effect and, like caffeinated coffee, tea, or soft drinks, is harmful to the voice by robbing the throat of its much-needed water content. Alcohol should be greatly curtailed and/or discontinued, especially in the presence of other disease that may add more stress to the vocal tract (e.g., a respiratory infection).

#### Treatment of Vocal Abuse

The vast majority of vocal abuses may be reversed completely with medical therapy to modify the singer's habits. Surgical treatment is reserved for irreversible changes of the vocal folds (e.g. polyps).

#### **Medical Therapy**

A. Vocal Health and Hygiene

Good vocal hygiene requires hydration to enhance normal mucus production and lessen vocal stress. Eight to ten large glasses of non-caffeinated, non-alcoholic fluid each day are essential, and the list of beverages may be used as a guide to finding those fluids that are beneficial to mucus production:

- 1. Water
- 2. Fruit juices
- 3. Non-caffeinated soft drinks, such as:
  - a. Seven-Up or Ginger Ale
  - b. Caffeine-free Pepsi or Coke products, or RC-100
- 4. Decaffeinated coffee or tea, and herbal teas

#### B. Adjunctive Care of the Voice

Voice use *including singing or speaking* should be sharply curtailed in the presence of throat irritation. Whispering delays vocal fold recovery because of the tremendous tension needed to produce a whisper. Instead, an easy, effortless voice production will lead to a quicker recovery. Total voice rest may cause problems with timely recovery in some cases. Your local otolaryngologist or speech therapist should be consulted in those situations where voice problems last more than two weeks. Finally, adequate nasal breathing will ensure a normal moist, warm, and clean environment for the throat and larynx.

A professional vocal coach will find the most efficient form of voice production for you. An effort should be made, even for shorter times of three to six month intervals, to study voice and singing techniques regularly from a professional music teacher, or voice or speech therapist. Help will be gained through:

- a) training the singer in the proper techniques of singing and relaxation;
- b) educating the ears in what it sounds like to sing properly;
- c) helping the touch sensations of the head and neck "feel" a properly generated sound.

#### C. Special Care for the Church Musician

A number of special helps are available to get past troubled times and prevent permanent vocal injury. The following list of remedies is first steps in the progress toward *substantial* change of habit for prevention of future voice problems.

- 1. If you must sing, lower the singing pitch slightly (e.g. two whole steps).
- 2. Sing in a soft, easy tone without forcing the voice.
- 3. Use a microphone, or turn up the one already being used.
- 4. Signify mood changes or intensities by singing softer, not louder. A softer sound often portrays more intensity and piety at the same time.
- 5. Shorten the total time of voice use.
- 6. Don't raise your vocal pitch when either getting excited or trying to excite the singers or congregation. Let the text do the work.
- 7. Let others (deacons, chanters, altar boys, readers) do the readings.

**Surgical Therapy** 

When abuse of the voice becomes permanent, it is impossible to improve the voice without intervening surgically to remove a mass or excess tissue that has formed. The most common, benign, permanent lesion of the vocal fold is a *polyp*, forming after months of vocal abuse. Removal violates the vocal fold *mucosa*, which must then heal, forming scar tissue in the process. Even in the best of surgical hands there is no guarantee that the patient will not have permanent voice trouble after the operation, for there is no control over the healing part of the recovery process. Therefore, preventing polyp formation is a key to long-term vocal health.

#### Conclusion

The best way to treat voice disorders is to prevent them before they occur. The care of the voice is of paramount importance to the singer who cares enough about the voice to want to keep it in excellent form. By recognizing the earliest signs and symptoms of vocal abuse, and attending to voice preservation techniques, the Orthodox church musician will be better able to enjoy a long and healthy period of use of their most important organ of communication and prayer.


