Anna Yortzidis's journey into Greek folk dance began in 1985 with the Hellenic Youth Dancers at Sts. Constantine and Helen Greek Orthodox Church in Newport News, Virginia. Her passion and dedication are seen by her representing her community at prominent events such as the Metropolis of New Jersey Folk Dance Festival, Metropolis of San Francisco Folk Dance Festival, and the Metropolis of Atlanta Hellenic Dance Festival.

After 16 years of dancing with the Hellenic Youth Dancers, Anna stepped into the role of program head, where she directed five dance groups. During this period, she conducted extensive research on the traditional dances of various Greek regions, including Thrace, Pontos, Macedonia, Crete, and the islands. Her enthusiasm for costumes led her to significantly enrich the group's costume library, while she continued performing with the adult group, Enosis.

Anna's commitment extends beyond directing. She has also provided her expertise as a judge at prestigious dance competitions including the Metropolis of Atlanta Hellenic Dance Festival, the Direct Archdiocese District Folk Dance Festival (Parathosi) in New York, and the Metropolis of San Francisco Folk Dance Festival.

In 2012, alongside her husband Aris Yortzidis, she co-founded the Byzantio Cultural Arts and Dance Program, which has since flourished in the Greater Washington DC area. Based in the Greater Metropolitan Washington, DC area, Byzantio is dedicated to celebrating and preserving Greek heritage through traditional dance, music, song, costume, and mentorship.

Chrysoula (Chrysa) Malogianni was born and raised in Thessaloniki, Greece, a city renowned for its deep roots in Greek cultural tradition and dance. From a young age, she immersed herself in the dances of Greece, specializing in the traditions of regions such as Macedonia, Thrace, Epirus, the Islands, Pontos, and her family roots of Sarakatsanoi and Vlachoi. By the age of 17, she was already directing and teaching Greek dance to children and adults, showcasing her early passion for preserving and promoting traditional Greek culture.

She studied at Aristotle University of Thessaloniki in the School of Education, where she selected coursework focusing on Greek traditions and cultural education, including advanced studies in Greek cultural practices and methodologies for teaching dance. Her academic foundation, combined with formal research training, enabled her to maintain and expand the study of Greek folk traditions. This training has fueled her lifelong dedication to researching and preserving the cultural nuances of regional Greek dances.

She has traveled extensively throughout Greece, engaging in fieldwork to study dances from regions such as Thrace, Epirus, Macedonia, and Pontos. She collaborates with fellow Greek dance researchers, continually contributing to the study and documentation of traditional Greek dances. Her annual trips to Greece involve action research, attending cultural festivals, and working alongside local experts to deepen her understanding of the sociocultural significance of Greek folk dancing and traditions.

After relocating to the United States, she continued her involvement in Greek dance as a director in Charleston, SC, and Newport News, VA. She has been an active participant in the Hellenic Dance Festival (HDF), contributing as a performer, director, and mentor, helping to sustain the vibrant tradition of Greek dance within the Greek-American community.

Efthymia Alexiou is dedicated to preserving and sharing the rich traditions of Greek folk dance. Her journey began at the age of three in San Francisco, CA, where she competed in the Greek Folk Dance Festival for 15 years. During this time, her group earned numerous awards for their performances, representing the regions of Epirus, Macedonia, and Thrace, and were recognized for their authentic and passionate interpretations of these regional styles.

Efthymia's love for Greek culture naturally led her to teaching. She spent several years instructing primary-level dance groups at Holy Trinity Greek Orthodox Church, instilling a love for dance and tradition in the next generation. From 2003 to 2006, she expanded her teaching to the University of California, Berkeley, where she offered a Greek Folk Dance course that explored the dance, music, and cultural history of Greece.

A long-standing member of the Byzantio Cultural Arts and Dance program since its inception in 2012, Efthymia has been instrumental in the preservation and promotion of Greek folk traditions. She currently teaches the elementary school-level dance group at St. Katherine's Greek Orthodox Church in Falls Church, VA, continuing to inspire young dancers with her deep knowledge of Greek culture.

In addition to her teaching, Efthymia has an extensive background in traditional Greek folk costumes. She is well-versed in all aspects of costume-making, including material selection, embroidery, weaving, and costume presentation—ensuring that every performance is

authentic and culturally accurate.

Efthymia is also a novice Daouli (Greek drum) player, further deepening her connection to Greek music and dance. She believes that Greek folk dance programs play a crucial role in preserving cultural heritage, connecting communities to their roots, and ensuring that these traditions live on for future generations.

Eleni is originally from Chicago where she attended Roosevelt University's Chicago Musical College and studied Classical Ballet and Spanish Dance, and is considered a Dance Master.

Eleni traveled throughout Greece studying and collecting information and knowledge to share with her students and the Greek community. She studied with the Dora Stratou Dancers in Athens, The Nelly Demoglou Folklore Theater in Rhodes and many seminars and workshops conducted by the Likion ton Ellinidon, in Greece and the US. She conducted extensive research at the Benaki Museum in Athens, the Peloponesian Folklore Foundation in Nafplion, the Museum of Folk Art in Athens, and the Folklore Museums in Kozani and Ioannina, and recently the Victoria Karelia Costume Collection in Kalamata.

1990, Eleni became the first Greek-American to be selected by the Greek Government to participate in an educational, fact-finding expedition, conducting personal interviews with people in many villages ranging from Macedonia to the Island of Castelorizzo to record village costumes, customs, and dances.

Eleni has conducted numerous dance clinics and seminars. In 1984, she founded the first Greek Dance Conference in the Southeast which was held in Atlanta, Georgia. In this conference, she stressed the learning and sharing of knowledge gained through research and study. Eleni has traveled throughout the southeast teaching Greek culture and dance.

To date, she has taught classes in numerous parishes of the Atlanta Metropolis. and conducted many presentations for the Fulton, Dekalb, Cobb, and Gwinnett Public School system, the Carter Library, the King Center, the Atlanta History Center, The Carlos Museum at Emory University, The High Museum, and the Georgia Historic Preservation Association.

In the 1996 Centennial Olympic Games in Atlanta, Eleni was a consultant to the choreographer of the Opening Ceremonies and was a key player in the orchestration of the "Tradition of the Games" section of this spectacular ceremony. In 1998, she was recognized by the San Francisco Metropolis Folk Dance Festival Board of Trustees for her commitment to the preservation Greek heritage through dance and music.

In the fall of 1998, she accompanied her husband to Brussels, Belgium, where they were attached to the American Embassy, in support of United States Government diplomatic mission. Upon receiving a Letter of Introduction from the Likion Ellinidon in Athens, Greece, the Likion Ellinidon in Brussels appointed her to the Board of Directors as the Director of Dance.

Eleni has served as a member of the board of directors of various foundations and societies dedicated to the preservation and education of the Greek culture. These organizations include: Troupe Hellas Greek Folkloric Society, Inc., Atlanta, Georgia; Hiphaistia, Traditional Greek Folkloric Society, Larissa, Greece; Hellas Greek Folkloric

Society, Clearwater, Florida; Laographia Greek American cultural Society, Astoria, New York; Alpha National Association for the Preservation of Hellenic Language and Culture; Parthenon Dancers, Athens, Greece; The Atlanta Folks International Cultural Association, Atlanta, Georgia, the Likion Ton Ellinidon, Brussels, Belgium, and the first President of the Likion Ellinidon in Atlanta, Georgia. She has also served as the Vice Chairman of the Board of Directors to the Hellenic Dance Festival, Atlanta Metropolis and served as Co- Chairman of the Dance Odyssey scholarship program.

Eleni served as a dance and costume judge in Greek Folk Dance Festivals (FDF) on both coasts, Chicago, and the Metropolis of Atlanta's Hellenic Dance Festival and was honored as Director of the Year at the 2014 Hellenic Dance Festival held in Orlando.

Upon returning to the United States, to Charleston, South Carolina, Eleni established the Dance ministry for Holy Trinity GOC. The Holy Trinity Dance ministry earned many medals for dance, and costumes throughout her tenure.

Eleni and her husband recently moved to Newport News, VA, and look forward to active participation in the Sts. Constantine and Helen community and their dance ministry.

John Lulias was raised in Tarpon Springs, Florida (Greek Town, USA), and is a second generation Greek American. John has been involved in the Greek community and Greek Folk Arts all of his life and learning Greek fluently as a child.



In 1974, after graduating from the University of Florida, he moved to Philadelphia, Pennsylvania, and became part of the Greek dance troupe, *Terpsichoreans*. It was there that he began to study and really learn the intricacies of Greek dance style and love for anything Greek.

Upon his return to Tarpon Springs in 1979, John formed the dance troupe *Levendia* and developed this group into one of the premier Greek folk dance troupes in the United States. He directed the group for more than 20 years. The group traveled throughout the United States and Canada, the Bahamas, and Greece, promoting, perpetuating, and preserving the Greek culture through song and dance.

John was co-curator of *The Dodecanese Islands*, an exhibit featuring artifacts, costumes, and recreated room settings from the Dodecanese Islands in Greece, at the Tarpon Springs Cultural Center. On October 3, 2003, John received a University of Florida (UF) award for his years of work teaching Greek dances. He has been on the Advisory Council of the Center for Greek Studies at UF.

John has done workshops throughout the United States, has been a judge at the Greek Folk Dance Festival in California, and was the founder of the Winter Dance Conference in Tarpon Springs. John was also on the first board that started the Hellenic Dance Festival for the Atlanta Metropolis. In 2014, John was awarded the Florida Folk Heritage Award for significant contributions to Florida's cultural heritage through his outstanding achievements as a lifelong advocate of traditional Greek dance.

Today John tries to keep Greece alive in the Tampa Bay area by helping with cultural exchanges, organizing events for the community, and bringing groups and travelers to Greece. The Greek roots instilled by his parents have played an important part in the lives of both John and his brother, Archbishop Nikitas of Great Britain and Thyateira.

She holds a B.A. in European History from the University of North Carolina at Chapel Hill and a Master of Arts in Teaching from Salem College, grounding her work in both historical scholarship and pedagogy.

Since 2003, Lisa has directed several groups within the Hellenic Dance Troupes of the Annunciation Greek Orthodox Church in Winston-Salem and has maintained continuous leadership roles on its dance board for more than twenty years. In this capacity, she has taught dancers of all ages and levels, organized regional workshops, collaborated with esteemed directors, mentors, and musicians nationally and internationally, and curated an extensive collection of traditional costumes. Her dancers have earned numerous honors, including multiple medals, folkloric expression distinctions, and choral awards at the Hellenic Dance Festival. Her contributions have been recognized with the Metropolitan Alexios Archangel Michael Award for exceptional service to parish youth through dance, as well as the Director Award at the 2010 AGDC Competition in Chicago.

At the Metropolis level, Lisa contributed to the early development of the Hellenic Dance Festival of the Metropolis of Atlanta, serving on its Executive Board in various roles, including Host Committee Chair, Judge Coordinator, and Merchandising Chair. With over three decades of teaching, performance, and research experience, her repertoire spans many regions of Greece; her enduring favorites include the Cyclades, Thraki, Thessaly, and Epirus. In 2025, she was awarded an Odyssey Scholarship alongside other directors supporting immersive field research on Apokriatika traditions in the Thessaloniki and Serres regions. Lisa remains deeply committed to mentoring the next generation of dance leaders and to dance as a community-centered, collaborative art rooted in lived tradition. She loves to spend her summers in Greece with her husband, Gus, and spirited children, Dafi and Vasoula, engaging fully in the traditions of local communities.
